Parte B. RESUMEN DEL CV

Jose M. Moneva is Full Professor of Accounting and Finance at the University of Zaragoza (UZ). His research on Sustainability and Social Responsibility begins with academic works in social and environmental accounting, highlighting the paper of the Spanish Journal of Accounting and Finance (1996, with F. Llana, 225 citations). The relationship with other groups, such as CICSMA led by prof. Carrasco and researchers from this area Carlos Larrinaga, Jan Bebbington (CSEAR Univ. St. Andrews), Roger Burritt (Australian National University) has allowed developing an accepted research in national and international academics. An example is the number of citations received (e.g. Bebbington, Larrinaga & Moneva, 2008, 1.216-GoogleScholar). The collaboration with new researchers and groups Stefan Schaltegger (Center for Social Management-University of Leuphana), M^a Jesús Muñoz (Sogres-UJI), Michele Andreaus (Univ of Trento), Rodrigo Lozano (University of Gavle), CIRCE Institute has given rise to different projects and scientific works of high impact on the area. Thus, Moneva, Rivera & Muñoz (2007), included in the meta-analysis of the most relevant works of CSR, Aigle et al (2008, Business Ethics). In recent years, I have been a principal researcher of several competitive projects, highlighting four in MICINN R&D calls, in which the bulk of research in recent years has been developed. At the UZ, I am the coordinator of a research group of excellence, fourth in Economics and Business according to regional evaluation (<https://ecocircular.unizar.es/>). High impact scientific production is achieved, with 38 JIF articles (including 21 Q1 and 13 Q2) and a high h-index in terms of the area (WOS h-index 21). Throughout these years have been a guest speaker at national and international conferences, highlighting my participation in 2 symposia of the European Accounting Association. More than 100 communications have been presented to conferences, a large part are international with external review. He is member (or former) of international committees on CSR: FEE Sustainability Group, Global Reporting Initiative Economic Subgroup and the European Sustainability Reporting Association. In research supervising, he advised 11 theses, two with international mention and currently is advising 4 more. Tutor of a Fellow of the Aragonese

Government, who will be part of the project team. The lines of research that are intended to be developed in the medium and long term are those initiated in previous research projects, which have also begun to bear results in the form of publications of the area (Management, Business, Accounting, Finance) with high impact (Supply Chain Mgmt, Sust Acc. Mgt & Policy JI; Jnal of Business Ethics, Corp. Social Resp. & Env Mgt). The collaboration already initiated with CIRCE and other engineering research group specialized in energy and resource efficiency implies a step forward, by introducing the basis of the circular economy in the measurement and accounting of sustainability performance. He teaches in degree and master in subjects on social and environmental accounting in two Official Masters (one on Circular Economy). He is also co-director of the postgraduate degree in CSR Management (UZ). Finally, since 2006, he has been working in various management tasks and currently is Dean of the Faculty of Economics and Business of UZ.
