**Parte B. FREE SUMMARY OF THE CURRICULUM**

My research career is shown in a set of publications in high-impact journals, included in the Scopus and JCR indices, as well as book chapters and complete books published by publishers of national and international character, all of them located in the first positions of quality evaluation. All the publications carried out in recent years are intended for the analysis of public policies aimed at to cities, specifically with respect to the extent to which public policies address the new challenges that urban and metropolitan areas face each other.

During these years I have maintained a close collaboration with the public administration, specifically the ministries responsible for financing and managing European urban development programmes, which has been strengthened in the framework of the development of an urban agenda for Spain, once the urban agenda has been established for Europe, as well as the United Nations New Urban Agenda. As well as with various administrations regions such as Andalusia or the Basque Country, in which he has collaborated, along with the rest of my team research, in its design. In this sense, collaboration and common reflection with those responsible for the management of public administration, as well as the knowledge obtained from carrying out various works of research, has highlighted the need to delve into Spanish urban policy and, specifically, its degree of alignment with the implementation models proposed from the European level.

This analysis work at a European level has led me to establish a stable collaboration network with other researchers concerned with similar questions. This materializes in the development of works and publications with researchers from universities such as Autónoma de Madrid, Politécnica de Madrid, Barcelona, Oxford Brooks and Milan Polytechnic. In this last institution I was able to carry out, during 2015, a stay of research, from which we could incorporate a new line of work that is very useful for the objectives of my research, such as the mechanisms approach applied to the analysis of public policies. This line of work has culminated in the creation of the Research Group on Urban and Metropolitan Governance (GUM-Z) (Sej 606) for which I have been responsible for two years. Within the framework of this line, a total of 5 PhDs have been generated, which have culminated in the publication of scientific articles in high-impact journals, as well as the recognition for the best doctoral thesis in two cases.
